

Unapproved minutes from March SIRS meeting

SIRS RC/CL Model Club

April 10, 2017 SIRS Minutes

Vice-President Bob Stadsholt opened the meeting at 6:55 at the flying field..

Members present were: Ken Ausli, John Siebert, Greg Vertrees, Ethan Jett, Jeff Simpson, and John Burrill.

Guests present: Matt, Zack, Terry Husted, Gary Schollman.

Bob reviewed the minutes from the last meeting.

Treasurer John Burrill reported the club has \$5,816.91 on deposit and 23 paid members as of April 7, 2017.

The minutes and treasurer's report were approved on a motion by Greg Vertrees, seconded by John Siebert.

Old Business

Bob reminded members of the pylon racing event coming up June 24 and 25, and that we will need 10 volunteers for same. He circulated a sign-up sheet. Jerry Worden requested that the lumber in the shed be saved until after the pylon racing in case we need it for making protective cages.

Continuing discussion on the use of power poles for vehicle barriers took place. Jerry and Justin are checking on the source of poles for availability and handling issues.

Bob brought up the matter of rolling the flying field with a road (asphalt) roller. The cost would be \$500.00 delivered plus fuel for a 48" wide 6 ton roller. Bob also indicated he would make a partial donation to help cover the cost.

John Burrill moved that we go ahead with the rental and open the expense up for additional donations by those members who wish to help cover it. Motion was seconded by John Siebert. After considerable discussion the vote was taken and was carried 4 to 2.

New Business

Several items for discussion from John Cralley were brought to the meeting in his absence:

- Suggestion that we change the time of the summer meetings at the field to afternoon to get away from the late meetings and perhaps improve attendance. This was discussed and it was noted that there is no contravention of this in the constitution or by-laws. No decision was taken, but it was offered that we could simply announce a different time (3:00 PM was suggested) and change it again or any time if desired. It was also suggested that we could poll the membership by email to get a feeling of how members felt.
- 2. Suggestion that we donate a subscription to the AMA magazine to each of the local libraries. There was general agreement. This would be a positive in our goal of becoming a Leader Club. No action taken or assigned.
- 3. Suggestion of a monthly evening "gathering day" other than the meeting, possibly to include a cook out. No discussion on this (running out of time).
- 4. Suggestion that we encourage members to bring things for "show and tell". No discussion.
- 5. Should we circulate a list of paid members with contact information? The suggestion again was to poll the membership on this and all of these proposals.
- 6. Suggestion: a "classified" section in the newsletter. General agreement and also encouraging ads for vendors.
- 7. Rumor is that Hobbyland may be sold this year. Is there anything we can do to help make sure someone purchases and keeps it running? Very little discussion, other than to note that the retail world is changing greatly.

Message from the AMA!!

Dear members,

As you've probably heard by now, a federal appeals court today struck down the FAA's registration requirement for recreational model aircraft.

Today's Court ruling is effective immediately. As such, if you have not registered with the FAA, you are no longer required under the law to do so. For those of you who have already registered with the FAA, you may be wondering what this means for you. We are currently working to obtain answers from the FAA and will share more information as it becomes available.

Please keep in mind that this is a fluid situation and there is always the possibility of a renewed push in Congress to compel federal registration for model aircraft. If that happens, rest assured that AMA will continue to advocate for your interests and keep you well informed every step of the way. We have repeatedly argued that federal registration for our community is duplicative and unnecessary, as our members already register their model aircraft with AMA. In addition, our 80-year history of safe and responsible flying demonstrates that we're not the problem. We shouldn't be burdened by overly broad regulations.

Today's ruling also bodes well for our pending court challenge to the FAA's interpretation of the Special Rule for Model Aircraft (also known as the Interpretative Rule). That petition, which AMA filed in 2014, is currently before the same Court that today rejected the FAA's registration rule and affirmed the strength of the Special Rule for Model Aircraft, otherwise known as Section 336. This gives us hope for our continued fight against the Interpretive Rule.

We understand that these policy and legal developments are sometimes dizzying and complicated, and they are rarely resolved quickly. We're nearly three years into our challenge to the Interpretive Rule, for example. We truly appreciate your sticking with us while we press on in the fight to protect your right to fly, free from unnecessary and burdensome restrictions.
